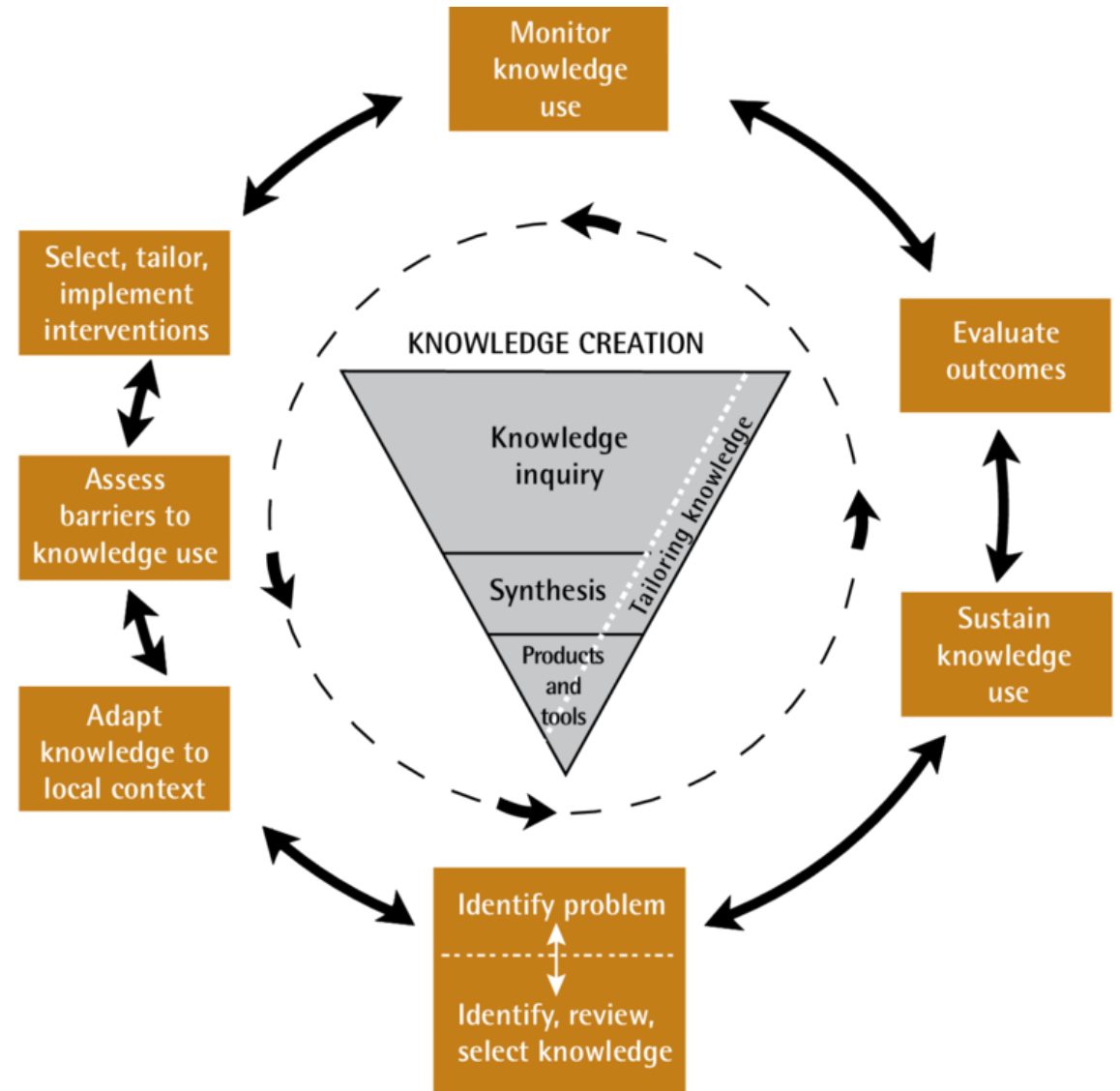

# Knowledge Translation

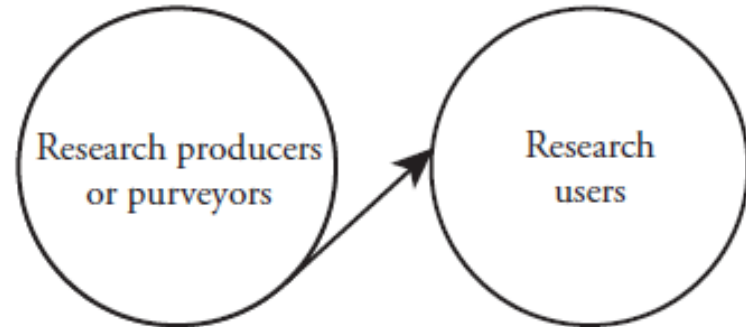
- World Health Organization definition:

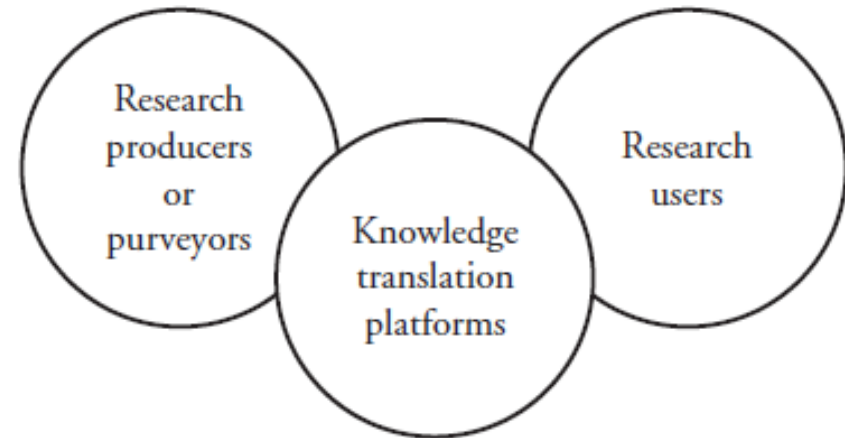

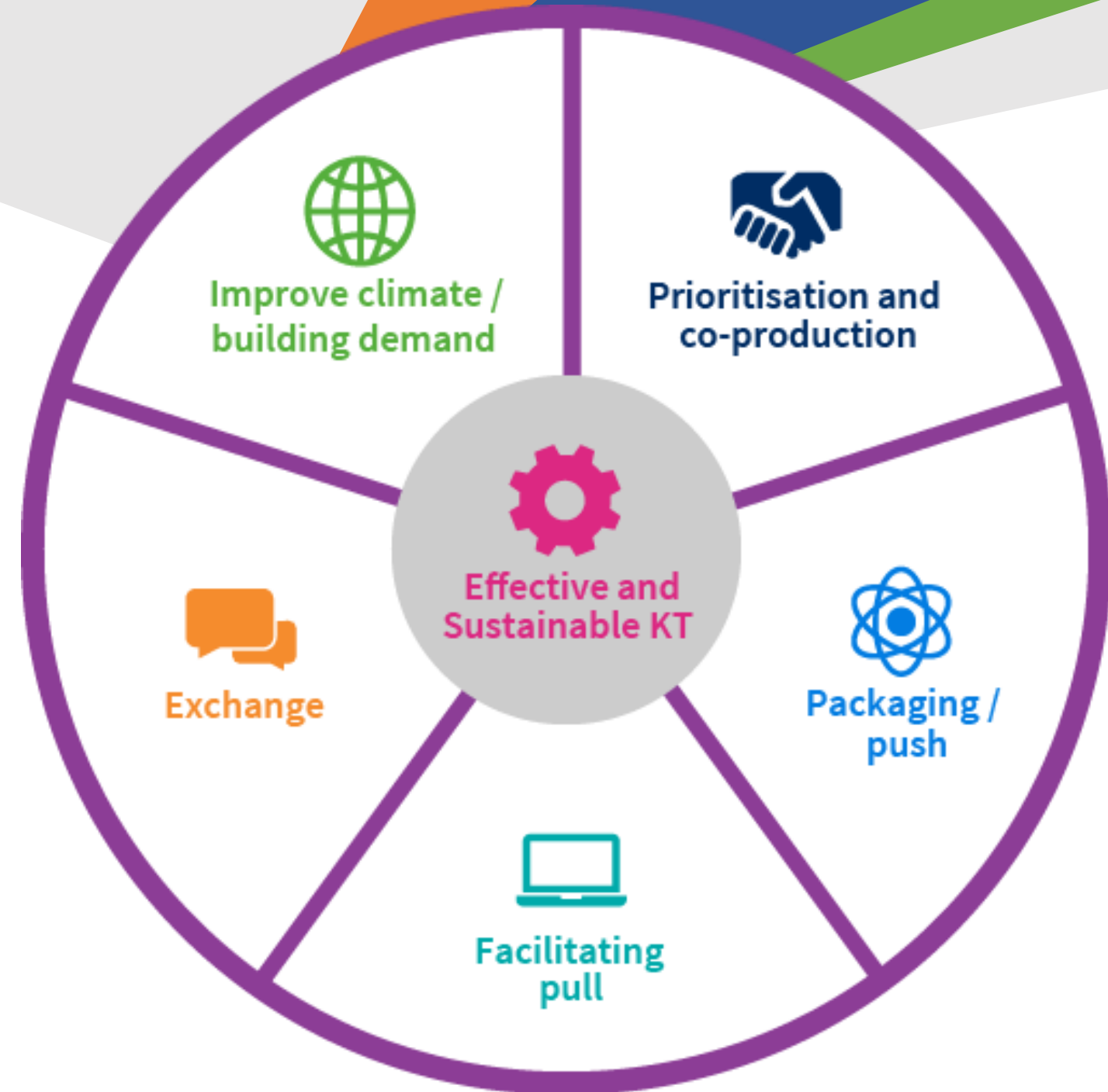

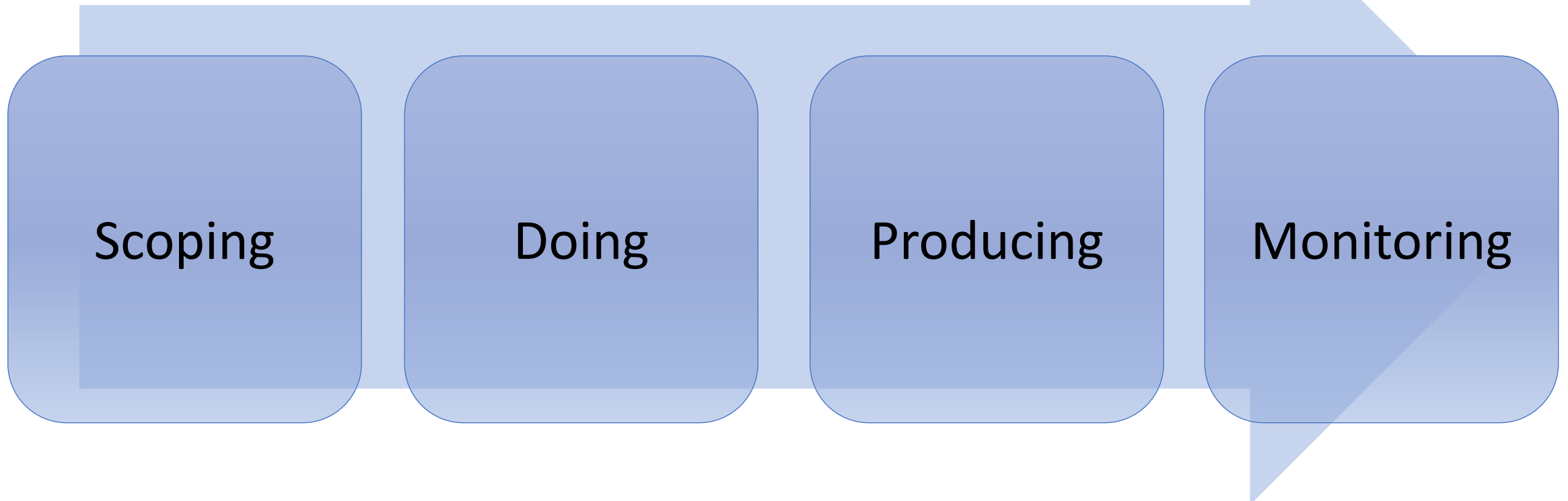

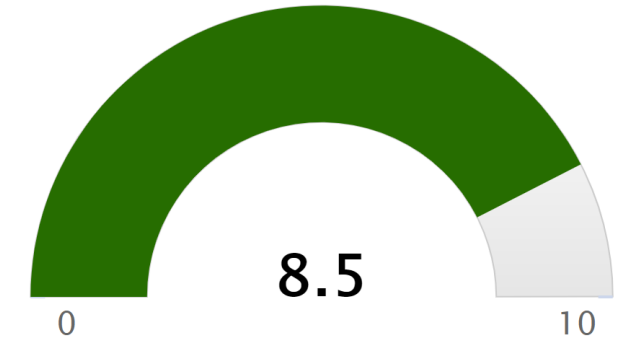
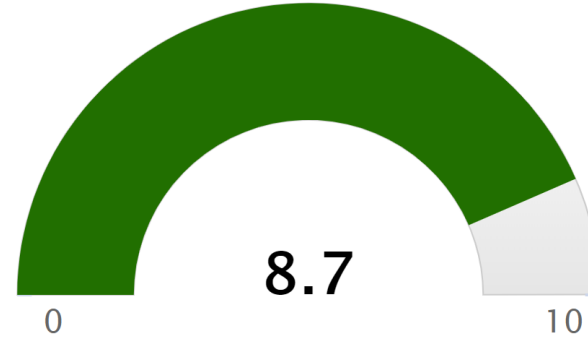
- We developed a web-based survey of twenty-nine (n=29) questions, sent out via email to 105 participants within the Cost Action CA18218 European Burden of Disease Network [burden-eu].
- We received 6-50 responses for each of the questions. The questions focused on disability-adjusted life years (DALYs), years of life lost (YLLs) and years lived with disability (YLDs) for non-communicable diseases (NCDs), injuries, infectious diseases including Covid-19.
- Most participants indicated that they consider calculating Covid-19 BoD (60%) and its indirect effects on NCDs (62%), but not on injuries (14%). 84% indicated that they consider quite or very important to develop a knowledge translation toolkit. Participants also indicated methodological challenges such as accessing resources and interpreting long-term impact data.

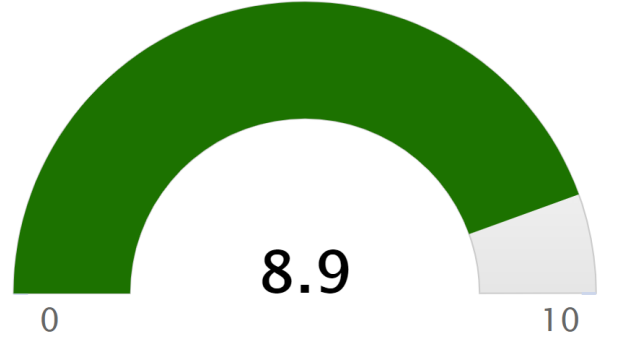
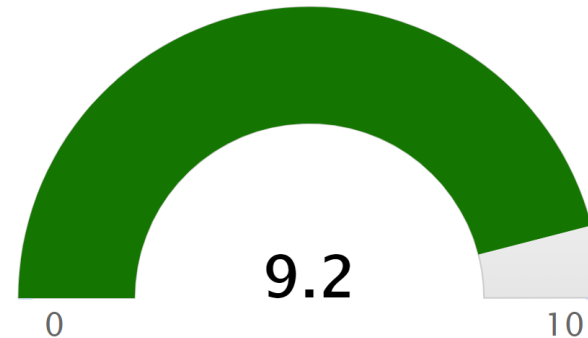
On scale from 1 to 10, how satisfied were you with the TS in general?

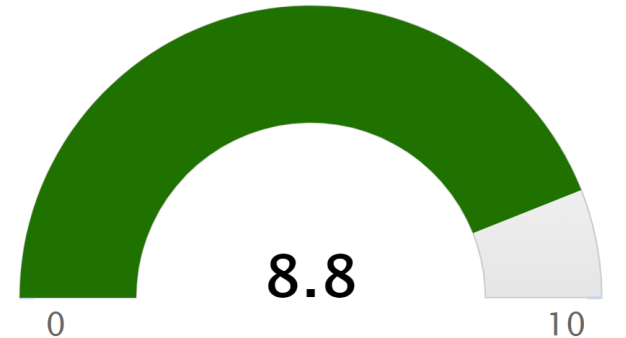
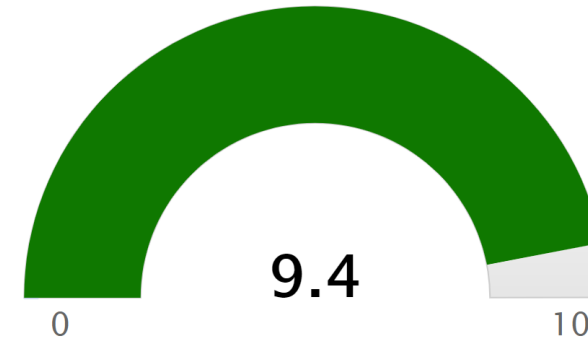
On a scale from 1 to 10, how would you rate the **contents** of the course?

On a scale from 1 to 10, how would you rate the **organization** of the course?

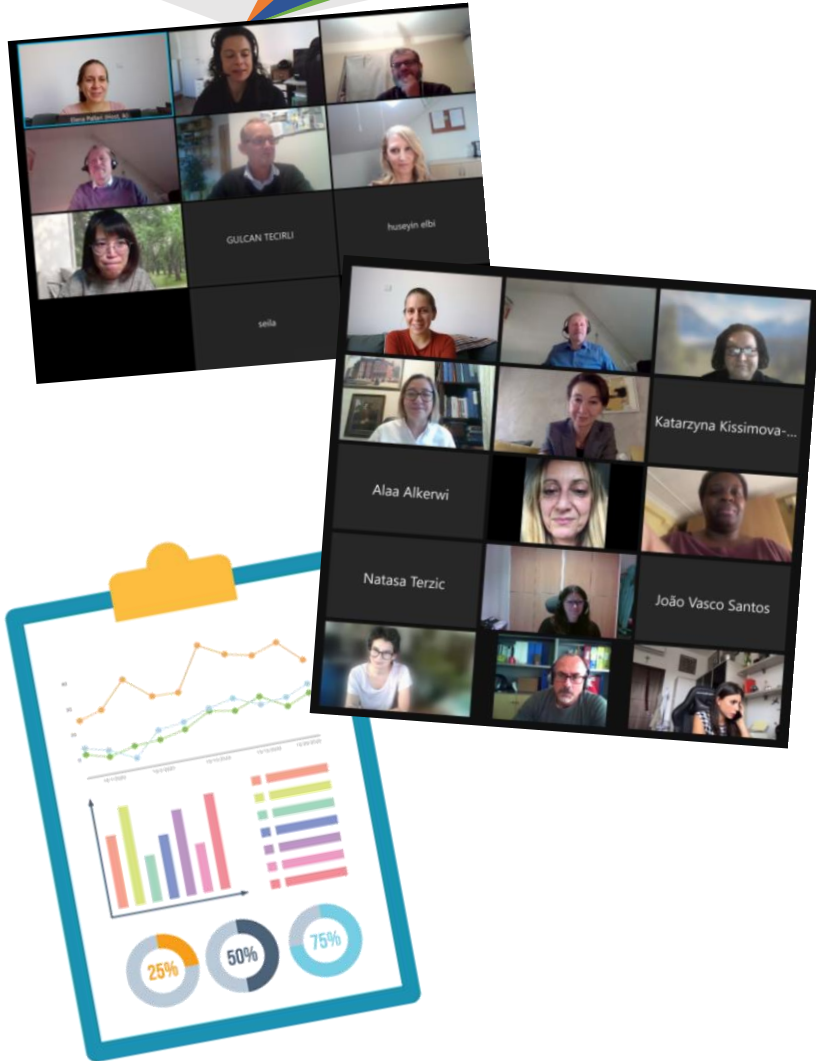

# Virtual sessions of KT working group



- Establish who has a mandate for BoD (e.g. National Institute for Public Health)
- Think of simplified ways of explaining the concepts of BoD
- How to link regional, national and global BoD initiatives
